MARZOCCHI POMPE S.p.A. COMMUNICATES THAT URBAN 90 S.r.l. INCREASES ITS SHAREHOLDING BY MORE THAN 4%

Bologna, December 2nd, 2020 – **Marzocchi Pompe S.p.A.** (AIM:MARP), leading company in the design, production and marketing of high performance gear pumps and motors, listed on the AIM Italia Market managed by Borsa Italiana, announces that Urban 90 S.r.l. - a company controlled by Marzocchi Pompe's Chief Executive Officer Gabriele Bonfiglioli - has purchased 9,500 shares on the market, thus increasing its stake in Marzocchi Pompe S.p.A. to 4.15%.

The share purchase has already been communicated in compliance with Internal Dealing regulations.

Gabriele Bonfiglioli, Chief Executive Officer of Marzocchi Pompe and main shareholder of Urban 90 S.r.l. commented: "I know very well Marzocchi Pompe, where I started working in 1992, and its characteristics that have made it one of the main players worldwide in the gear pump sector. All our employees, including those in foreign offices, make up a team that stands out for its competence and team spirit, a key issue in such a difficult year.

All this confirms my deep belief in our capability to create added value and in our growth prospects, reinforced by commercial initiatives and new product development, which are proceeding relentlessly. I therefore wanted to give a message of confidence, which I believe is particularly important in such a volatile phase for the equity market that is penalising solid realities such as Marzocchi Pompe, whose fundamentals are not reflected in the current share price, even according to the latest analyst report published".

Marzocchi Pompe is a leading company in the design, production and marketing of high performance gear pumps and motors, which find application in various fields: industrial, mobile and automotive. It closed 2019 with approximately 40 million euros in sales revenues. Founded in 1949, it is controlled by the Marzocchi family, which holds the majority of the shares and is present in the company with Paolo Marzocchi, Chairman, and his son Carlo, in the Technical Area. CEO Gabriele Bonfiglioli and four other managers are also part of the shareholding structure. Production is carried out entirely in Italy at the two sites in Casalecchio di Reno (BO) and Zola Predosa (BO). Marzocchi Pompe is present in over 50 countries through an international distribution network.
