MARZOCCHI POMPE JOINS THE "INVESTOR ACCESS" EVENT IN PARIS

Bologna, 5 October 2022 - Marzocchi Pompe S.p.A. (EGM:MARP), a leading company in the design, manufacture and marketing of high-performance gear pumps and motors, will meet institutional investors at Investor Access in Paris on Thursday, 6 October 2022.

The event, organised in Paris by Investor Access in partnership with leading European financial market players, including Integrae SIM, is dedicated to **mid-cap companies listed in Europe**. It aims to showcase the best companies to a **broad audience of international institutional investors**, with one-to-one or small group meetings.

The meetings will be attended by the Management of Marzocchi Pompe, presenting the economic and financial results for the first half of 2022, as well as the Group's business model and strategy.

Gabriele Bonfiglioli, CEO of Marzocchi Pompe stated: *"After the presentation of the excellent 2022 half-year results by videoconference to Institutional Investors, the "Investor Access" in Paris in presence represents a further important moment of meeting with financial market operators, both Italian and international.*

The first half of 2022 showed record revenues and a substantially stable EBITDA compared to 1H 2021, confirming the maximum levels of the pre-Covid era despite the significant increase in costs, mainly energy costs. This once again demonstrates Marzocchi Pompe's capability to cope with market adversity with fast and effective actions such as a targeted increase in inventories and renegotiation of sale prices, in order to quickly bring EBITDA margin also back to the record levels of 1H 2021. Despite the still difficult global scenario, we are very confident about Marzocchi Pompe's future prospects."
